Report by Roy Roach on the Children's Home. Offer of free meal at Children's Home on Thursday Night for anyone who wants to stay over. In addition to his written report he also gave a power point presentation showing the increase in giving over the years. He also pointed out that the Children's Home debt had decreased from \$493,000 to \$193,824.27 in just three years.

Nomination of Cyrcus Shoffner as Youth Ministries Director for a 5 year term (2013) was approved. Nomination of Marty Cox to serve until 2013 was approved. Nomination of Royce Home to replace the unfulfilled term of Cliff Wilson (2012) was approved.

Verbal FWB Bible College Report was given by President, Matt Pinson. In addition to information about the programs in the College and the Online Bible Courses available, President Pinson shared that relocation was going forward but everyone needed to continue to pray and support the work. MSC to receive as information.

State Treasurer's Report was given by Marty Cox. (See Appendix 5) MSC

Report was given by Missionaries to Spain Tim and Kristi Johnson. He gave a verbal report supplemented by a Power Point presentation of the work in Spain.

A report from FWB International Missions was given by Steve Lytle about the impact of South Carolina Missionaries on the Ministry of International Missions. Everyone was encouraged to participate in the April World Mission Offering. MSC to receive as information.

15 minute break

Song led by Bruce Kimbrell "I will sing of my Redeemer" Led in prayer by John Driggers.

Nomination of Paul Childers for a 7 year term on the Children's Home Board (2015) MSC.

Nomination of Kenneth Cash for a 3 year term on the Finance / Credential Committee (2011). MSC.

Report of FWB Foundation by David Brown. Report of FWB Retirement by Ray Lewis. MSC to receive as information.

Report on Randall House Publisher by Ron Hunter. He shared about various books and helps that are available to Churches and Pastors through Randall House. MSC to receive as information.

Report from Southeastern College by President Lorenzo Stox. Several projects and upcoming events were mentioned. MSC to accept as Information.

Moderator Sherwood Lee shared about the early ministry of the State Office and the work of Norwood Gibson in getting churches to support ministries through the State Office. He shared that the State Office is more than a building; it is a ministry to the FWB people of South Carolina.

Executive Secretary, Todd Smith, shared thanks to all the faithful Pastors and workers in our state for their hard work and vision in getting us to where we are today. All ministers 60 and older were recognized and appreciated. The women and the WAC were recognized and told how much they were appreciated. Former Executive Secretaries were recognized for their service.

Todd Smith shared about the needs of our Foreign Missionaries, and then shared the financial reports for the various departments. A power point presentation about the history of the State Office was then presented. We then dismissed to the State Office on Atkinson St in Turbeville for the official Dedication Service.

After re-assembling at the new State Office / Book Store Executive Secretary, Todd Smith, introduced the visiting dignitaries from the town of Turbeville and then asked Moderator Sherwood Lee to pray the dedication Prayer. The Dignitaries from the town of Turbeville and the state executive committee observed as Sherwood Lee and Mike Jones cut the Ribbon to the newly dedicated State Office Building releasing the key into the hands of Executive Secretary Todd Smith. Following the ribbon cutting the mayor of Turbeville welcomed SCFWB to the City and everyone was asked to come in and tour the new facility.

Thursday Night

State Executive Secretary, Todd Smith, presented a plaque to Horse Branch for being the Top Giver in the State through the Plan of Support in 2007. Opening song led by Bruce Kimbrell.

The Horse Branch Praise Team sang during the Evening Offering (Designated for the State General Fund).

Sherwood Lee introduced President Matt Pinson, president of the FWB Bible College, as our guest speaker. Another special by the Horse Branch praise team before Dr. Pinson came to speak

Scripture reading from Gal 3:1 and prayer before he began preaching on the topic "How to Hold Forth the Word of Life".

Dr Pinson stated that Christians today are in danger of becoming foolish and thoughtless by allowing experience driven worship to become the driving force in many churches. Christians today are being bewitched (To charm as with an evil eye) by Satan as he uses the "bait and switch" tactic to get people to see one thing but end up with something different. He does this in order to seduce us from the kingdom priorities of Christ.

He also stated that we are becoming more and more addicted to electronic media and to the success symptom. Our goal now seems to be to meet relative needs instead of redemptive truths. Because of this the Church has begun adopting principles of Big Business, of Media Entertainment, and of Scio- therapy marketing instead of the principles of the word of God.

The only way to combat these problems is to set Christ evidently before men. This originally meant that a picture of Christ must be set before men in such a way until they could really see the Power and Person of Christ.

Finally, Dr Pinson proclaimed that the church today must exhort and convince our hearers into hearing and obeying the truth, proclaim the truth through Biblical and Scriptural preaching, and adopt a total personality approach in our preaching that will engage the mind, emotions, and will of our congregations.

Final Credential Committee Report by Marty Cox. Total Attendance 145. (84 Ministers, 15 Delegates, 46 Visitors). MSC (See Appendix 15)

Report of Gateway Christian College by David Postlewaite which included a DVD presentation. MSC to receive as information.

Report of Resolutions Committee. Read by Clerk. MSC to accept. More information was given about a bill presently before the S C Lawmakers concerning gambling in Churches. (See Appendix 13)

The Moderator asked for General Business. None was presented.

Dr. Don Hanna gave a report on the work in India. He informed us about a problem with Missionary Carlisle Hanna's visa and urged us to pray. He reported that 2 churches have been built since Brother Carlisle's return - one on the Nepal Border. The Annual Conference was held this year with attendance of 3000 due to the shut down of the Nepal Border and the inability of the people in the north to attend because of a transportation strike. 38 People were baptized at conference this year. 549 new believer came into the Church in North India in 2007. He also mentioned the need of continued prayer for the strength and wisdom of Missionary Hanna.

Dr. Hanna said he would be in India during the month of March doing medical missionary work.

After several questions about the work it was requested that the congregation gather around the altar to pray for this great need. Led in prayer by Brian Tolliver.

2007 SCFWB State Executive Committee Minutes

SCFWB Executive Committee Meeting, Thursday, April 26, 2007

The SCFWB Executive Committee met on Thursday, April 26, 2007 at the SCFWB Home for Children in Turbeville, S C in a called meeting to discuss the sale and relocation of the SCFWB State Office. Present for this meeting were Moderator Sherwood Lee, Assistant Moderator Buddy Seay, Jr., State Treasurer Marty Cox, State Clerk Mike Jones, and Member at Large Doug Mathis. Also present were SCFWB Executive Secretary Todd Smith and Mr. James Beasley, a local contractor in the Turbeville area.

The Moderator presented the bids that had been received on the State Office Property at 1705 S. Irby St. in Florence and asked for discussion. After a period of discussion and questions it was MSC to accept the \$285,000 bid by Mr. Joe Jebaily.

It was then MSC to authorize Moderator Sherwood Lee and Executive Secretary Todd Smith to sign the paperwork necessary to sell the property.

The Executive Committee then adjourned in order to meet with the Relocation Committee appointed at the 2007 State Association Meeting. This meeting also took place at the SCFWB Home for Children in Turbeville, S C. Present for this meeting were the individuals listed for the SCFWB Executive Committee meeting, the Home for Children Board (Chairman, Tim Hackett, Larry Collins, Allen Goodman, Larry Hawkins, Paul Childers, Eddie Hinson), and Children's Home Director, Roy Roach.

This joint session began with Scripture Reading by Buddy Seay (Psalm 133) and prayer by Tim Hackett.

SCFWB Moderator Sherwood Lee informed the Relocation Committee of the Executive Committee's decision to accept the bid on the present State Property and then asked for input about locating the new State Office facility. Local Builder James Beasley shared his willingness to assist the Free Will Baptists of South Carolina in building this new State Office with the condition that he receives no compensation for his work and that the SCFWB State Office be charged with paying the bills charged by the Subcontractors. He shared the fact that with this arrangement he felt sure the new State Office Building could be constructed, including parking and landscaping, within the budget of the sale price of the Old State Office Property. He also stated that he believed the work could be completed by the end of September, 2007.

Due to the non availability of water and sewage on the property adjacent to Highway 378, Mr. Beasley suggested that the new State Office / Book Store Building be constructed on Atkinson Street just beyond the Children Home Director's home.

MSC to use the land on Atkinson Street beside the Children's Home Director's home to build the new SCFWB State Office / Book Store Complex.

MSC to adjourn.

SCFWB Executive Committee Meeting., Thursday, May 31, 2007

A called meeting of the SCFWB Executive Committee was held at the SCFWB Home for Children on Thursday, May 31, 2007. All Board Members and the State Executive Secretary, Todd Smith, were present. We were led in an opening prayer by Moderator, Sherwood Lee.

MSC to acknowledge a gift of \$100,000 to the SCFWB State Office from Jebaily Enterprises, Inc. and to approve a Corporate Resolution to sell the SCFWB State Office property at 1705 South Irby Street in Florence for \$185, 000 to Jebaily Family Limited Partnership.

MSC to ask all the Conferences in the State to host the 2008 State Association Meeting at Horse Branch FWB Church of Turbeville, S C on February 28-29, 2008. The SCFWB Executive Secretary is to request that each Conference give \$500 toward the expense of this State Meeting.

The program for the 2008 State Meeting was discussed and approved. Date: February 28-29, 2008. Location: Horse Branch FWB Church of Turbeville, S C. Theme: "Holding Forth the Word of Life" from Philippians 2:16. Speakers: Thursday Morning Devotion- Rev. Chad West (BC). Thursday Noon Message- Rev. Wayland Owens (SCC). Thursday Afternoon- Dedication of New State Office/Book Store Complex with message by SCFWB Moderator, Rev. Sherwood Lee. Thursday Night Speaker- Dr. Matt Pinson, President of Free Will Baptist Bible College, Nashville, TN. Friday Morning Devotion- Rev Jody Wynn (SCC). Friday Morning Message- Rev. Johnny Evans (EC). The Thursday Noon meal will be served at the SCFWB Home for Children. The Friday Noon meal will be served at Horse Branch FWB Church.

Children's Home Board Chairman, Tim Hackett, Assistant Chairman, Larry Hawkins, and Children's Home Director, Roy Roach came to the Board to present a petition from the Clarendon County School Board District Number Three to purchase 2 acres of land located on Atkinson Street beside the new SCFWB State Office / Book Store Complex.

MSC to call a special State Meeting at 10:00am on Thursday, June 21, 2007 at Horse Branch FWB Church of Turbeville to present this proposal with the recommendation from the SCFWB Executive Board that the State Association sell from 1.8 to 2 acres of land for \$20,000 to the Clarendon County School District Number 3.

Motion, Second, Carried to adjourn.

A Special Called Meeting of the South Carolina State Association of Original Free Will Baptists, Inc. was held on Thursday, June 21, 2007 at Horse Branch FWB Church of Turbeville, S. C. in order to act on the following Motion:

Acting on a recommendation from the SCFWB Children's Home Board, the Executive Committee of the South Carolina State Association of Original Free Will Baptists, Inc. moves that the South Carolina State Association sell 2 acres of land located on Atkinson Street in Turbeville to the Clarendon County School Board District Number Three for \$20,000.

In February 1979, the South Carolina Free Will Baptist State Association elected Rev. Norwood Gibson as the Promotional Secretary for a two year term, in which he was to develop that position into a full time position. The great task of this challenge was presented in Bro. Norwood's own words: "When I began the work of this office and set out to accomplish the task given me I was not sure how, nor how quickly, it could be done." It was in August 1980, a little over a year later, that Bro. Norwood Gibson resigned his pastorate and assumed the position as Promotional Secretary on a full time basis. Starting out with just a type writer in hand, Bro. Norwood logged a total income through the state office reported at the 1980 state meeting at \$3,003.37 coming from various churches across the state. This amount would grow to \$441,951.21 in 1995. It was under Bro. Norwood's leadership that the "Pop Willey Missions Offering" was initiated that disbursed funds between Home Missions and Foreign Missions. In 1989, it was also under his leadership that the State Association voted to authorize a General Board form of government which would provide board budgets and a structure to our state organization. In 1992, under his leadership and sacrifice, the South Carolina Free Will Baptist State Association purchased property in Florence, SC. The amount of this property purchase was \$100,000.00. This property would house the State Office and Christian Book and Supply until 2007.

In 1995, Bro. Norwood Gibson resigned his post as Promotional Secretary, and Rev. Ron Moore, assumed this position. However, Bro. Norwood, would stay on as a staff member of the State Office for the purpose of developing the bookstore as a ministry of the office. Under the leadership of Bro. Ron Moore as Promotional Secretary, a new Foreign Missions plan of support called the "South Carolina Foreign Missions Plan of Support" (SCPS) would be developed on a more strategic level. The giving through the state office would grow to \$719,287.65 during his term in office.

In 1999, Rev. Ron Moore resigned as Promotional Director, and Rev. Mike Jones assumed the position as Promotional Secretary, which would be changed to a title of Executive Secretary during his tenure in office. During Bro. Mike Jones' eight years in office, the giving through the state office would increase to \$1.2 million dollars. Also, during his time in office, the \$30,000.00 remodel debt would be paid off, the Christian Book and Supply would continue distributing Sunday School literature to our churches, a South Carolina Free Will Baptist web site would be developed (www.scfwb.com) providing a great wealth of knowledge and resources for our conferences, churches, and ministers; and a vision would be cast for relocating our state office to Turbeville, SC, to be located on our Children's Home property.

In 2007, Rev. Todd Smith assumed the position as Executive Secretary. It was in 2007 that the Florence property at 1705 S. Irby Street in Florence was sold for \$285,000.00, and a new state office was built at 1169 Atkinson Street in Turbeville, SC, on the Free Will Baptist Home for Children's campus.

The South Carolina Free Will Baptist State Office continues to serve the needs of our conferences, churches, pastors, Women Active for Christ, Free Will Baptist church members, and lay leadership. The Christian Book Store continues to meet the needs of churches and individuals by providing Sunday School literature, church supplies, Vacation Bible School materials, books, and many other needs.

The *Informers*, the South Carolina Free Will Baptist state paper, continues to be published to almost 4,000 individual or churches in South Carolina and in other parts of the country.

We are here to serve you in whatever capacity we can. If we can help in any way, please don't hesitate to let us know. It is an honor to serve the Lord amongst Free Will Baptist in this great state of South Carolina!

STATE HOME MISSIONS REPORT

Submitted by Board Member Theron Scott (SC) in the absence of Director Earl Hendrix.

These are exciting days in the Lord's work in SC State Home Missions.

We are very thankful for the continued Hispanic work of Bro. Gerardo Rodriguez and Bro. Fernando

Bustamante and the Hispanic pastors under his direction. We continue to see much fruit in Spartanburg, Columbia, Florence, Effingham, and Conway areas. One note about the financial support of the Hispanic missions...We have not been receiving enough finances to underwrite these ministries. Please note on your financial report under CELF SAVINGS ACCOUNT that we have had to draw from the savings pretty heavily the latter part of the year to provide for their salaries. We certainly encourage your support of our state Hispanic works as well as the Aiken work.

The Aiken work went through a struggle this past year during the transition from Bro. Todd Smith becoming our State Executive Secretary to a seeking and finding his replacement. Quite a few months past. We are thankful to Bro. Westley Murray who served as intern for a while and then several others who helped supply the pulpit while we sought the Lord for the missionary God would have to serve in the Aiken work.

In August and September we became acquainted with and interviewed Bro. Jim Fairchild. After an extensive and encouraging meeting, we were impressed with Bro. Fairchild and his experience and credentials. Bro. Jim answered the call to preach at age 16 and graduated from Southeastern FWB College in 1998. Sensing the Lord's will very strongly toward his selection, the board voted to hire Bro. Jim as our home missionary to Aiken.

The Aiken work is now under the SC State Home Mission Board and is no longer a joint project with the National. Any financial support that comes through the National is forwarded to the SC State Home Missions board for Bro. Fairchild's support. We do encourage you to contact Bro. Fairchild and have him come and speak...get acquainted and let him share his burden for the work with you. He is available on Wednesday nights for this purpose.

On a very positive note, because of your gracious support, the Aiken Loan Fund balance has been paid down to \$82,595.46 as of Dec. 31, 2007.

In order to have our churches in the state more informed and supportive, the SC State Home Mission Board has initiated the organization of regional home mission conferences. These conferences will be held with local area FWB churches within the locale of each of our board members. They will be held on Sunday evenings with our State Home missionaries as guest speakers. My family and I want to thank you for your loving support in our ministry and we thank God for the love he has given you for the Hispanic Ministry. We are really happy with what God is doing in our community. This is the resume for the year 2007.

We are still distributing tracks and Bibles in our community. We have given around 150 Bibles in Conway, 100 in Florence, and 100 in Columbia this year. We have 7 home meeting in Conway and Florence and 3 in Columbia. Last year, we also gave around 700 tracks and 500 chicks.

In our Christmas service we had around 120 people. Approximately 50 percent of those people did not know the Lord and twenty received the Lord during that service.

We have a radio program every Sunday. It reaches six neighboring cities.

We have started a church in Conway. It has around forty-five people. They are new believers. Twelve have been baptized. We are also starting a Worship Team. Our major goal is to reach more souls for Christ this upcoming year.

Our church in Columbia, with Pastor Antonio Jimenez, continues to grow with fifty-five members attending every Sunday, following the vision of the Great Commission.

In addition to trying to unpack and set up the apartment, I began an intensive six-month language course that will end March 28th. I also have been getting 'up to speed' as part of the Hokkaido Team. The Team is working to reach this city of 127,000 people with the Good News. I help with the monthly outreach event—Ebetsu Alive—preparing the PowerPoint program, playing guitar in the worship band and helping in the planning for the event. I'm also responsible for the music for services in the Miharashidai church plant. From early summer I will be teaching Bible classes again and some SS classes, helping with women's outreach programs, helping with E-Team, and assisting in other areas as needed.

Please continue to pray for:

1. Wisdom for the Team in presenting the Gospel to the unreached of Ebetsu City
2. Spiritual growth of Japanese Christians
3. Needed funding for new career personnel
4. My continuing rehab as I recover from the 2007 back surgery
