**Report, Home Missions general work,** Tim Larrimore. Aiken work is doing well. The Hispanic ministry is also doing well. The board is considering putting a home mission church in Moncks Corner, SC, please pray for this new work. The church in Pamplico is being repaired, once repaired the church will be sold and the monies put into the home missions account. MSC

**Report, Aiken Home Mission,** Randy Valandingham. During the past year the church has had 21 salvation decisions, 17 rededications, and 11 baptisms. The church now has 32 members and is averaging 40 – 50 on Sunday attendance. The church now has a mobile home for the pastor and his family to live in. Move to receive report. MSC

**Report, Friends of India,** Mike Jones. Thanks to all who have contributed to the work in India. The India work has a goal of building 2 churches each year. The church planters are being supported to enable them to try and win 2 souls daily to the Lord. Widows of Christian workers and boys are supported annually. Bro. Hanna thanked the SC churches for the offering from 2016 that was used to build a new FWB church in India. The church is built and filled. Please keep all our churches and properties in prayer. Travel Visa issues continue to be a problem. A missionary visa was no longer allowed, an employment visa is now needed. There are also monetary issues for India and the Indian currency. Annual conference is just a few weeks away. With the current financial issues, the conference is facing many issues with the need to be able to help those who come to the conference. We're still going and preaching the gospel in India. We have been sent to India to make Christ known. Jeremiah 32:27, "Behold, I am the LORD, the God of all flesh: is there any thing too hard for me?" Jeremiah 33:3 "Call unto me, and I will answer thee, and shew thee great and mighty things, which thou knowest not." We will continue to trust God in all our work in India. **Report, Keith Burden,** NAFWB Executive Office. Please take advantage of the FWB magazine, "ONE." Also available online. A DVD has been developed to help churches put together a security plan for their churches. A revitalization program is being developed for churches that are struggling. The NAFWB convention is in July in Louisville, Ky. Thanks for the financial support to the National office. There was a decline in 2015 in the Together plan, but there has been a gain during 2016. FWB still holds to the doctrine that we have believed, we are not changing. Our directive is still to "GO" into all the world. Received as information.

**Report, Todd Smith,** FWB Foundation. Provided information regarding Financial Management, Planned Giving, & Estate Planning. The Foundation is available and would like to come to our FWB churches to present their program. Information can be found online through the national website or a link is available on [www.scfwb.org](http://www.scfwb.org). Christians are encouraged to consider "planned giving" and "planned gifts" through the Foundation. Christians are also encouraged to consider the Lord's work in the end of life planning through the Estate Planning program. The opportunity is available to give sacrificially to the Lord now and also after we go home to be with the Lord.

**Report, NAFWB North American Ministries,** David Crowe is represented by Rick Bowling. The financial report was given with the following details. Final 2016 financial numbers, the church extension loan fund had record gifts and loans. The North American Missions offering was \$736,739 for 2016. This shatters the previous record by almost \$300,000. This was the greatest year financially and we ended the year in the black. The Porto Rico church went self-supporting in Jan. 2017.

**Report, International Missions,** Sam McVay. Thanks for more than \$465,000 given to international missions for 2016. The board voted in 2015 to move back to designated giving as the method used to provide funds for our missionaries. The giving for 2016 is up from 2015. The general fund had enough funds available to erase all accounts that was in the red. Please support our World Mission Offering that is on April 30, 2017. Videos are available on the website providing information on our world missions. The Hanna project is providing medical and construction needs at our various world mission's locations.

**Report for Welch College,** a video was shared about our students at Welch College, Mike Edwards brings greetings to our association. Thanks for your support to our college. Please give to the scholarship funds for the college. Students will move to their new home on March 4 in Gallatin, Tn. Dr. Jeff Cockrell provided some details on the new Welch College Master's Program. There are some scholarships available for FWB pastors. The program involves online work and a one-week intensive program. Received as information.

**Report, David Womac,** Randall House. The report of 2015 showed severe losses. The audit for 2016 shows that we will close in the black. This is a great turn-around. Our obstacles are declining churches, lessening discipleship and other issues that Christian publishing is facing. We are praying that families will take an active role on family discipleship and Randall House has material available to assist in this most important need. Parents must take an active role. Strong families make strong and active churches.

**Report, Mike Jones** showed pics of New Life FWB Church that was built from donated funds at the 2016 meeting.

**Report, Free Will Baptist Family Ministries** of Greenville, Tn., Bro. Robert Travis. The ministries had 155 salvation decisions, 89 baptisms, and 6 rededications during 2016. The Hope Center had 102 babies born and 269 families receiving help through the Hope Center. The drug & alcohol abuse center had 64 young boys graduate. The

assisted living for the elderly are finding assistance through the Family Ministries. The ministry has also started an in-home help program for handicapped individuals. There are 162 kids in the program through Arkansas and 183 kids through the program in Tennessee. There are 107 kids in the foster care program.

**Final credentials** committee report given by Bro. Scott Ard. We have 6 conferences represented, 106 churches, received \$24,910 in fees/dues, 72 ministers, 15 delegates, 6 national reps, 4 missionaries, and 28 visitors with a total attendance of 125. Motion made to receive final credentials report. MSC

**Report received from the Resolutions Committee** is as follows: 1. Whereas there is clear scriptural teaching that we as ministers are to preach the Word, and whereas we have been adequately and appropriately challenged and reminded at this state meeting that we are to preach Christ and Him crucified, be it resolved that we recommit ourselves to the biblical mandate to preach the whole council of God, and to proclaim the absolute truth that there is none other name under Heaven given among men, whereby we must be saved. 2. Whereas we hold firm to the belief that God is still today calling young men into the Gospel ministry, and whereas there is a clear and present need for pastors within our state and denomination, be it resolved that we pray that FWB young men will surrender to God's call to local church ministry, and be it further resolved that we who have answered this call will make every effort to encourage, support, and mentor these young men so that they may remain faithful to Christian teachings and to FWB doctrine. 3. **SCFWB Disaster Relief Board**

The SC FWB Disaster Relief Board conducted the first meeting on Tuesday, June 21, 2016 in Columbia, SC. At that time the mission and vision of the ministry was determined. The scope of the SCDRT was discussed at length and was determined to include the following: Generator ministry, Blessing Buckets (cleaning supplies), Food prep and delivery, Clean up services in aftermath of disasters, Much out of homes damaged by floods, Repair to homes and property. In preparation for being able to respond to natural disasters, the SCDRT felt there was a need for an enclosed trailer to hold all supplies needed in emergency response situations. The National FWB Master’s Men generously donated a 16’ enclosed trailer to the SCDRT IN August, 2016. Another area where the SCDRT felt there was a need was to recruit volunteers to help in disaster situations. A state men’s retreat was planned for October 2016. The SCDRT held a conference call in mid-October concerning the men’s retreat and it was determined at that time to postpone the retreat due to the major impact that Hurricane Mathew had on the state of SC. The SCDRT used the scheduled men’s retreat date to deploy teams across the hurricane damaged areas. There were four teams deployed to help with various projects. The projects included: 1. Removal of large trees from a family’s home in Nichols. 2. Clean out and muck out three homes in the Hemingway area. 3. Sheetrock and debris removal of Piney Grove Church. 4. Delivery of generators and chainsaws to various needed areas.

The SCDRT held its second meeting on January 24 at the State Office in Turbeville, SC. At the meeting there were multiple decisions made concerning distribution of funds that were dedicated to the Nichols area. The designated funds for the Nichols area totaled \$6,000. The men’s retreat has been rescheduled for Saturday, April 29<sup>th</sup> in Turbeville, SC. The cost to attend will be \$15 and will include preaching, lunch, education of basic first aid, chainsaw safety and roofing. All men of the state are invited and encouraged to attend. The SCDRT has been active now for approximately 8 months and has already had a great impact on the families and churches that were impacted by Hurricane Matthew. Thank you for your continued support of this ministry as it grows. Prayerfully, South Carolina Disaster Relief Board.

- Requirements for Board Members

  - Position will be open to both male/female.
  - Must be willing & able to promote the efforts of this Board. (Travel, time, etc.)

  - Financial assistance will be given for repairs on a per case basis as funds are available.
  - This group will be to provide assistance on a case by case basis as outlined in our Mission Statement.
  - Though based out of a FWB church, volunteers will be assisting the community as a whole and will not be limited to FWB only.
  - We will not respond to individual requests, but will be willing to help mobilize when available.
  - All assistance is volunteer and without cost. However, should the repairs be covered and reimbursed by insurance, a donation to South Carolina State Office would be greatly appreciated and would help those less fortunate in the future.

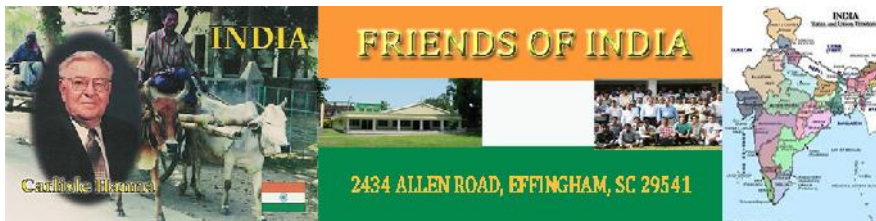
## Home Missions Board Meeting Minutes
